Solid Waste Hauling Terms & Conditions

EFFECTIVE September 9, 2021

Account requirements

- A credit card is required to open and maintain an account and is always to be kept current.
- Customer contact and email to be kept current for accounting purposes.

Payment

- By accepting services from ProRemovers you also accept the authorization of charges to be billed to credit card on file for services and fees. Recurring ACH form & Terms and Conditions are both to be signed for accounts to be active.
- **Once a container has been set, you will automatically be charged a container set fee to the card provided on file.** Once the initial container has been taken to landfill, we will bill the landfill separate. The next billing and dumping cycle will start with the HAULING MINIMUM TERMS.
- Invoices are due upon receipt and will automatically be charged to card on file unless previous arrangements have been made.

Pricing

Container Sitting Fee:

- 20 YD \$250.00 Max load 5.5 tons
- 30 YD \$350.00 Max load 8 tons
- *Customers are responsible for any damage to truck or container due to exceeding max.

Landfill Fees:

- determined by weight at time of tipping at landfill, reflected on invoice as landfill fees.

Additional Charges

Over fill line / Overload

- \$100.00 fee will be assessed for containers which are overloaded and/or not able to be tarped for safe transport.

Inaccessible Container

- \$100.00 fee will be assessed for containers that have been scheduled for service but are not accessible. Examples include when the container is blocked by vehicles or materials.

Move

- \$75.00 fee will be assessed for containers that need to be moved at customer request. Once the container is placed it is not to be moved unless by ProRemovers employees.

Hauling Minimum Terms

- **Containers are to be tipped a minimum of once every ten (10) calendar days.**
- Customers may schedule a dump and return service or a final pick up within the ten (10) calendar days and be charged Container Rental & Landfill fees with taxes.
- Should the customer choose not to have dump and return service or pickup within the ten (10) calendar days allotted then on the eleventh (11th) day the account will be charged a Sitting Fee of \$100.00. The Sitting Fee will be charged \$100.00 every ten (10) calendar days that the container has not been serviced with a dump & return or a pickup.

Service Area

- Containers are to be placed within twenty 25 miles of Fort Smith, containers placed 25-50 miles outside of Fort Smith will have an additional Trip Charge of \$50.00 each time the container is serviced or delivered. Maximum 50 miles. (Service areas to be updated as available)
- We do not currently service Oklahoma.
